Throw-over, 8 person capacity coastal inflatable liferaft with single floor, manufactured in accordance with Zodiac International drawing as listed in the attached Schedule of Approval. Packed in low profile GRP container N132 or Valise #4.

1. Approval is based on prototype testing witnessed by a Transport Canada Marine Safety Inspector.
2. Suitable for stowage at a height not in excess of 10 meters above light waterline.
3. Complies with Transport Canada Standards for Coastal Inflatable Life Raft – TP 11342.
